

Adored Again Seller Terms and Conditions

Welcome to Adored Again! By listing your wedding dress for sale on our platform, you agree to the following terms and conditions. Please read these carefully before proceeding.

1. Eligibility

- Sellers must be at least 18 years old and legally authorized to sell the wedding dress.

5. Shipping Requirements

- Once a dress is sold, the seller is responsible for securely packaging and shipping the dress to Adored Again within 2 business days.
- Tracking details must be provided to ensure the safe delivery of the dress.

6. Quality Control and Returns

- Dresses must be in the condition described in the listing. Adored Again reserves the right to inspect the dress upon receipt.
- If the dress does not match the description or arrives in poor condition, the sale may be canceled, and the seller will bear return shipping costs.
- In the event of buyer returns during the return/refund window, the dress will be shipped back to the seller unless otherwise agreed upon.

7. Liability and Indemnity

- Adored Again is not responsible for any loss or damage to the dress during shipping to or from Adored Again. Sellers are encouraged to insure their packages.
